4. Visitors-

a. KOA at the Florence River Park-Jason Messer of 2860 Melvina Canon City, presented a potential opportunity to collaborate with the City of Florence to bring a KOA campground to the City of Florence River Park.

5. Approval of Consent Agenda Items-
