ORDINANCE NO. 10-2015

AN ORDINANCE AMENDING THE FEE SCHEDULE FOR TRANSIENT MERCHANTS AND PUSHCART VENDORS

WHEREAS, the City Council is desirous of amending Section 9.16.040 of the Florence Municipal Code governing license fees for transient merchants and pushcart vendors.

NOW, THEREFORE, BE IT ORDAINED BY THE FLORENCE CITY COUNCIL AS FOLLOWS:

1. Section 9.16.040 (A) is repealed and reenacted to provided as follows:

9.16.040. Terms of license; fees.

A. Those peddlers, solicitors, transient merchants, or pushcart vendors desiring to peddle, solicit, sell or attempt to sell within the City shall make application to the City Clerk and, upon approval of said application, shall pay a fee pursuant to the following Schedule:

Peddlers, per day:.....	\$25.00
Solicitors, per day:.....	\$25.00
Transient merchants, per calendar year:.....	\$150.00
Pushcart vendors, per calendar year:.....	\$150.00

The fee for all days indicated on the application shall be payable in full upon approval of the application and shall be nonrefundable. No licensee shall be entitled to a license under this chapter unless the licensee exhibits to the City Clerk a current Colorado sales tax license and any other licenses required by law. The license, when issued, shall be valid for the number of consecutive days indicated on the application and approved by the City Clerk, commencing with the time of issuance and expiring at that same time on the last licensed day. If, upon expiration of the license, the licensee wishes to continue to conduct the licensed business in the City, the licensee must reapply for a new license, subject to the limitations of Section 9.16.050.

Introduced as an ordinance, passed on its first reading, assigned an ordinance number and ordered published in the *Florence Citizen*, the City's official newspaper on this 7 day of December, 2015.
